

In a recorded conversation between Joshua Farinella and two labor contractors, in January 2024, the contractors told Farinella that there were 150 female workers who had not had time off in over a year. They asked for permission to take the workers on an outing.

[00:00:00] Joshua Farinella: Yeah, yeah, come on in. Sit down. Sit, sit, relax. Sit, the chairs are comfortable. Alright, so what— what you were talking? You guys are both with Ras****?

[00:00:18] Joshua Farinella: Ras****'s boys. But we're talking about Sha****'s girls?

[00:00:21] Labor contractor: My wife is—

[00:00:25] Joshua Farinella: Oh, so your wife is—

[00:00:27] Labor contractor: My wife is the supervisor for all of them.

[00:00:31] Labor contractor: So today, she moves out all the girls and [inaudible] the last year we want [inaudible]. So, we want to go one day outside just for fun.

[00:00:48] Labor contractor: But not boys.

[00:00:49] Joshua Farinella: Okay. So you're saying that they haven't had a day off to actually do anything in over a year?

[00:00:57] Joshua Farinella: Yes, we will. We will put something together for them. Do they— Like, we're going to send them out as a group, right? Like 150? 150 going to wherever they want to—

[00:01:15] Labor contractor: You know, to do it on [inaudible], there isn't water or whatever it is. Once we go inside, it's a [inaudible] of water. [inaudible].

[00:01:28] Labor contractor: So this morning, [inaudible] in the water swimming pool [inaudible]. So we've gone there. So what? Then you go back. [inaudible]. They are asking one day.

[00:01:43] Joshua Farinella: Yes. Yes. I mean, they've— they haven't been on the property? Like, they've had days off to each go out by themselves, haven't they? Or have they just been on the property the entire time?

[00:02:04] Labor contractor: [inaudible] in a year only, but [inaudible] go outside [inaudible] in this place [inaudible].
