You should be able to import vannamei shrimp from India at a reduced duty by taking advantage of the Developing Countries Trading Scheme (DCTS). India qualifies for "standard preferences" under the scheme. There is government guidance here: https://link.edgepilot.com/s/d110cf0e/nQgt1PijkE_zwHJg-ErIFw?u=https://www.gov.uk/government/collections/trading-with-developing-nations

If you use the scheme, the import duties would be 4.2% for products falling under commodity codes starting with the digits 030617 and

If you see the scheme, the import duties would be 12% for products falling under commodity codes starting with the digits 030617 and 7.0% for commodity code 16052110.

Without the scheme, the import duties would be 12% for products falling under commodity codes starting with the digits 030617 and 20% for commodity code 16052110.

0306 would be the code for crustaceans that are shelled but still raw, or cooked but still in shell. Most of the prawns imported from India fall under 03061792.

1605 would be the commodity code if the shrimp were "prepared or preserved". In the case of vannamei, a product that has been both cooked and shelled would come under 1605. Imported prawns from India usually fall under

- 16052110 (in containers of 2kg or less),
- 16052190 (in containers of over 2kg) or
- 16052900 (in airtight containers).
