Samunnati Agro is not involved at any point of time in packing/ unpacking/ loading/ unloading of the Commodities and therefore, Samunnati Agro stands exonerated from civil or criminal liability for any risk arising out of and not limited to force majeure, accidents, transportation/ seizure of any contraband like narcotic drugs, spurious substances or any other.
- 10. Samunnati Agro stands exonerated from civil or criminal liability for any risk arising by way of misusing the invoice, way bill or any other document under which the Commodities are transported during the entire course of transit from the initial loading point to the destination point or to any other place to which the Commodities may get transported without authorisation in writing by Samunnati Agro.
- 11. Any dispute or claim that may arise in connection with this invoice or in relation to the same shall be referred to and resolved by arbitration of a sole arbitrator appointed by Samunnati Agro. The proceedings of the arbitration shall be governed by the Arbitration & Conciliation Act, 1996. The venue, seat of arbitration is in Chennai, Tamil Nadu, India and the language shall be English. The courts of Chennai shall have exclusive jurisdiction.
