- 1. Take few empty containers for temporarily loading bulk from store for breathing space and production storing. Approved . We already have 3 containers at the factory which are being loaded with finished goods and have 2 more containers reaching later tonight. We will have 2 more containers reach us tomorrow where in they would also be used for temporary storage.
- Arranging wooden pallets; chemical treated pallets will take more than 20 days .So proceeding with existing type pallets for the immediate requirement of 150

- numbers. Approved . We have worked out local sourcing where he has committed to delivering treated pallets next week. This order will be confirmed tomorrow with a meeting with the vendor
